# **Terms and conditions**

Lovens Spring promotion 2024

### I. General

These terms and conditions (the "promotional terms and conditions") apply to the Lovens promotion "free rain cover with the purchase of a Lovens Explorer model type: S85 AUTO ABS, S85 ABS, S85 AUTO, S85, S75 AUTO ABS, S75 ABS, S75 AUTO, S75, S50 in the period from 4 March to the 31st of May 2024 and are valid within that while stocks last". The value of the raincover is EUR. 360 (hereinafter referred to as: the "promotion") of Optima Cycles Trading B.V. (hereinafter referred to as: the "organiser"), established and having its office at Beveland 2 Beverwijk.

This purchase of the bicycle including a free accessory pack runs in the period from 4 March to 31 May 2024 (the "promotional period"). The invoice date must fall within this date. Registration to receive the rain cover is done via the promotion page. Registration is possible until June 30, 2024.

The organizer reserves the right to stop the promotion or to change the promotion conditions in the meantime, without giving any reason. A possibly revised version of the promotion conditions will be placed on the website of the organizer, with a date.

The organizer and the participants are bound by the content and provisions of these promotional terms and conditions. By participating in the promotion, the participant agrees to these promotion conditions. The promotion will be announced on May 1st, 2024.

# II. Promotional terms and conditions

The organizer is responsible for the delivery of the free accessories package to the relevant point of sale where the participant purchased the bicycle during the relevant period. The point of sale is responsible for the delivery of the accessory package to the participant and does not charge any additional costs for this.

Participation in the promotion is possible by purchasing a new Lovens Explorer BES3 type during the promotion period at an official Lovens point of sale and by completing the promotion form, submitting the invoice and registering the frame number of the bicycle on the Lovens promotion page. The consumer is responsible for registering the bicycle in a timely manner and providing the correct information to be eligible for the promotion.

Participation in this promotion is (exclusively) for persons who have purchased a Lovens Explorer during the promotion period at a Lovens points of sale and have registered the invoice with frame number on the promotion page.

Participation in this promotion is (exclusively) for the purchase of a new Lovens Explorer model, second-hand sales are excluded. Participation in this promotion is (exclusively) for persons who have reached the age of 18 years.

Employees at Optima Cycles B.V. are excluded from participation. Only one entry per person.

If the rain cover or LED daytime running lights are not immediately available for delivery, the delivery thereof will be moved to the first available date of delivery after registration of a maximum of 6 weeks. The promotion is valid while stocks last. This promotion is not valid in combination with other promotions.

In case of cancellation of the Lovens Explorer purchase, the promotion will lapse.

The organizer reserves the right to refuse entries that do not meet these conditions or appear fraudulent.
